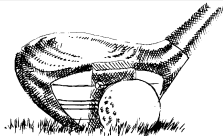

The Ministries of ECCCM:

In 2008 ECCCM provided over 2.8 million dollars in services.

Emergency Food Assistance

In 2008 ECCCM provided over \$882,111 of free food to qualified families in need in Catawba County.

Crisis Services

ECCCM provided \$82,000 of assistance with rent, utilities, oil, pharmacy & kerosene in 2008.

Children Services

ECCCM serves as the grantee agency for the Head Start Program in Catawba County. Currently 166 children are enrolled in this program located in four areas throughout Catawba County.

Other Community Services

Adult Basic Education Classes, Thrift Clothing Shop, blood pressure screening and help for burn outs. **USDA Food Commodities** (Federal Food program previously administered by Dept. of Social Service.)

C.R.I.S. (Crisis Response Intervention System)

A network of community agencies utilizing their combined resources to assist families in need.
